## A. Membership fees of the VPFA Ltd for 2018 are as follows:

enabling a non-member to exhibit at an affiliated Club Show	

Notes to the above schedule

- 1. The Board hopes members will increasingly access the Journal via the website. Its an environmentally friendly option which saves paper, time and postage costs.
  - 2. Members who prefer a hardcopy Journal, or who do not have the internet, can receive it at cost.
- 3. Junior membership (with access to ejournal via the internet) is now a very cheap option for young exhibitors and it will help families greatly as well.
  - 4. A Junior who prefers a hardcopy Journal can receive it at cost of printing and postage.
  - 5. Interested non-members who would like a hardcopy Journal can still receive it.
- 6. 'One Club Membership' is abolished and replaced by a \$10 'One Day Exhibitors Permit' for non members resident in Victoria who wish to exhibit at an Affiliated Club Show.

Please Note:

- a) There is no limit on how many times a non member can choose this option. The \$10 fee is payable each time the non member exhibits at an affiliated club show.
- b) The standard entry from to be used by our Affiliated Clubs will be altered to make provision for this option.
- c) Affiliated Clubs will collect the One Day Exhibitors Permit payment with the exhibitor's entry fees and send a cheque or bank transfer to the VPFA along with the exhibitors list from each affiliated show.
