5. Show Dates

A suggestion was made that clubs consider each having only one show in 2019 to simplify the calendar.

Central Western Club unable to hold Annual Show on June 2nd (date offered) as venue is leased by local football club. Only other possibility this year is weekend of July 21/22 when the OEG Club of Australia are holding their national show at Ballarat.
