The reason for this is that it includes eggs which aren't actually in the running for champion in show. It was decided that the rule would be changed. Not a good idea to change rule mid show season. VPFA Rules and Regulations Rule 69. Now reads

"A judge and his immediate family shall not be eligible to exhibit at the show he is adjudicating at.



This excludes egg judges who are solely judging eggs. Egg judges or their immediate family are permitted to exhibit birds in the show." (Reason for rule change is eggs are not eligible for champion in show.)
