SHOW RULES AND REGULATIONS.

1. These Show rules and regulations shall be enforced in conjunction with those of the Victorian Poultry Fanciers Association.
2. Exhibits must be the property of the exhibitor as shown on the entry form at least 14 days prior to the day of the show.
3. P&FSW PC shall not be liable for any loss, theft, or damage to any property, including Exhibits at the show.
4. P&FSW PC shall not be liable for any illness, disease or infection to any exhibit.
5. Judges are not liable to give placing to any exhibit that does not meet the minimal standard for the described breed.
6. Exhibitors are responsible for the feed and water of their own exhibits and may only do so after the completion of all judging.
7. Only judges may use judging sticks.
8. No Exhibit may be handled by anyone after penning except Judges. Stewards and the Show Manager.
9. The Show Manager may have an exhibit removed from the show at any time for any reason.
10. No person may interfere with the judging process if they are not on the judging panel.
11. Junior exhibitors must be under the age of 16 as defined by the VPFA.
12. Cockerel and Pullets must be under 12 months of age.
13. All entries must conform to the current VPFA Standard Schedule Edition 6 2024.
